**AUGMENTATION WATER PURCHASE**

Less than 0.028 acre feet (in-house use only well)	\$2,667.00 (flat fee)
0.028 acre feet to 0.099 acre feet	\$5,000.00 (flat fee)
0.10 acre feet to 0.79 acre feet	Amount of water x 1.25 x \$40,000.00 (example: 0.5 AF x 1.25 x \$40,000 = \$25,000.00)
0.80 acre feet to 0.99 acre feet	\$39,500.00 (flat fee)
1.0 acre feet and above	\$40,000.00 x amount of water (example: 1.1 AF x \$40,000 = \$44,000.00)

\* NOTE: Some Applicants for wells used for commercial purposes must lease additional water to replace post-pumping depletions. If applicable, Applicants will be informed of the lease amount upon HASP's review of the application.

**APPLICATION FEE (one-time payment)**

Application Fee – Single Family Residential (one lot and one user)	\$200.00 *
Application Fee – All Others (subdivision - multiple lots and/or multiple users - commercial)	\$500.00 <u>plus</u> \$1,000.00 retainer *

\* NOTE: Per ¶ 2 of the HASP's Rules, HASP may assess a *supplemental amount* if necessary to cover additional fees and costs incurred processing the application, including but not limited to administrative, attorneys, engineers, and consulting fees. Applicant shall be responsible for all costs and fees incurred processing the application regardless of whether Applicant ultimately purchases or leases water from HASP. The retainer will be accounted for and any unused portion returned at closing or upon withdrawal of an application.

## **MISCELLANEOUS FEES**

Augmentation certificate transfer fee: (with sale or transfer of one property only)	\$200.00 (includes recording fee).
Augmentation certificate revision/reissue: (other than with sale or transfer of one property)	Actual costs incurred to revise, reissue and record the certificate.
Failure to file diversion/measuring records:	\$100.00 per instance, plus any fees or costs incurred by HASP for obtaining the measuring record.
Late Fee:	\$100 assessed for each 30-day period the Annual Fee is late.
NSF Fee (insufficient funds/returned check):	\$50 assessed per returned item.
Trucking Fees:	To be determined at time of trucking, if applicable.
Storage Vessel Fee <sup>1</sup> :	Up to \$5,000 annually (adjusted by the Denver - Boulder CPI).
